We shall be testing on the hour. Classes will be held at 8:00AM, 9:00AM and 10:00AM on a first come first served basis

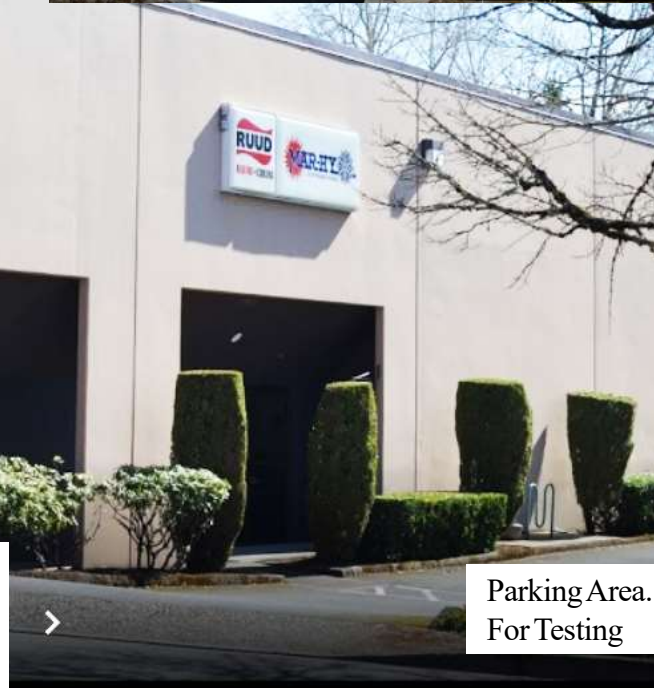

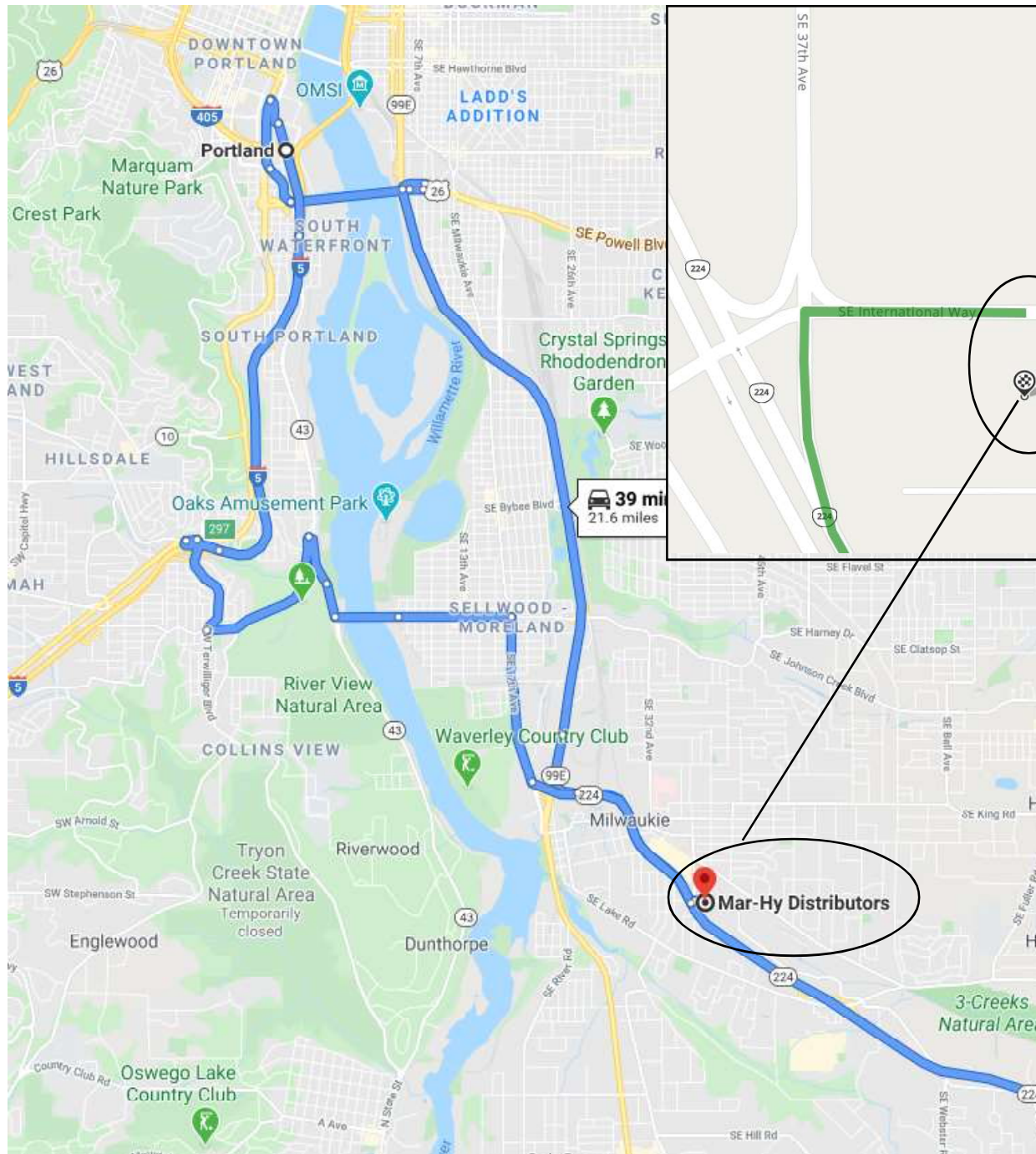

Parking for Practical test kit pick up is the second entrance to the building at will call area.

Practical test for brazing certification process

- 1. First you must contact ORACCA office (360-834-3800) at dan@oracca.org with your intention to take the test on Friday, May 20th. first come first served.**
- 2. You will be assigned a testing time, since class size will be limited. Test time will be limit to one hour for the written test.**
- 3. If you also need the Practical test, see below. Do this on the May 20th test date.**

We'll handle the practical another way. To get credit for the Practical, we are asking all participants, need to pass the written test, perform the Practical portion on your own and bring the finished brazement to the written test. You will be asked to sign an affidavit at that time, stating that you did the brazing Practical test.

If you need the materials for the Practical test, you may obtain them at the Mar-Hy facility starting Monday, May 20th, 2022. Each kit will have a 2 ft section of 3/4 OD copper tubing, one stick of 15% Silfos, two 3/4" LT fittings and one 3/4" coupling. Otherwise stock from your shop or truck is acceptable.

IMPORTANT STUDENT INFORMATION

- √ •During this session, our presenter will review the pertinent sections of the ORACCA manual.

- √ •The Seminar will be scheduled no sooner than a week after receipt of the test order. This gives the student sufficient time to review the text prior to the test. We shall no longer have a class lecture on the matter contained in the text before the test. Instead, we will send each participant a logon and password to access on demand video of the material to be studied. Each participant will be responsible for using the study material and video to prepare for the test. The written test will be followed by the practical brazing lab. The course for the written portion of the Brazing Certification test will be sent, upon registration. The written test is composed of a question, multiple choice test. The answers to the test are contained in the study material, so if you do not know, you may not pass. Your choice! Please spend time going over the study material. Do not expect to walk into the test. The odds are against it. We send this information so that you can prepare for the material involved in the test.

- √ •The tests will be scored by ORACCA headquarters, P.O. Box 1949, Vancouver, WA. 98661.

- √ •In order to obtain certification, applicants must pass the written exam, in addition to successful completion of the practical lab brazing test. (80% is passing on written test and cumulative voids on practical lab is passing for the lab).

- √ •Materials required for the Test are: 15% Silfloss and copper lab materials, **both supplied by ORACCA**.

- √ •**Each examinee must provide their own Oxy-Acetylene or B-tank Acetylene-air torch, measuring, cutting and reaming tools and consumables (scotchbrite pad, plumbers tape, cleaning clothes, etc.). No maap gas sets will be provided.**

- √ •**The cost for this certification exam is \$325.00 per participant, all ORACCA member employees may take the course for a discounted fee of \$225.00.**

To insure a firm reservation for the exam, return this form **with your check, or credit card information** for the appropriate amount. Space is limited for participants, per session...so register early. If you miss your registration date, there is a \$35.00 rescheduling fee to reassign you to the future class.
