Geneator Update

Many natural gas generators can automatically start when the power goes out. They can power a customer's furnace, refrigerator, some lights, and important appliances they rely on during emergencies, such as the television or radio.

If a residential customer asks about installing a natural gas generator at their home, homeowners or contractors should call NW Natural at 503-220-2360 before estimating the project. NW Natural can verify if the homeowner's current residential meter, service line, and houseline will need upgrades to handle the added load of a natural gas generator.

This work began in 2008 with early research in Oregon on energy labels and has continued through work with Earth Advantage in the implementation of energy labels in 16 states in all regions of the country. Heslam gained insight into the need for energy labeling during the 15 years he spent designing, building, and remodeling homes in Portland, OR. His national award-winning company, Coho Construction Services Inc., became known as a local and national leader for adopting new technologies and striving for high levels of sustainability. He built a Zero Energy home in 2004 and a Zero Water home the year before. Heslam's work at Earth Advantage has included the development of software, research into the effectiveness of energy audits, research into the feasibility of labeling systems, implementation of programs to enable the valuation of green and efficient homes, plus education for designers, contractors, REALTORS, bankers and appraisers about high performance homes.

Ryan LaPoma, Senior Education Manager - Ryan leads Earth Advantage's training and education partnerships with utilities, governments, and workforce organizations. Ryan develops educational strategies to increase equity and opportunities for historically underserved populations in the building industry, support energy efficiency program implementation, and promote overall market adoption of green building practices. He is responsible for overseeing Earth Advantage's curriculum development, high-production-value video training modules, and the development of multiple online learning programs. He has over 16 years of experience in guiding education-based programs that serve students. He is an ambassador and liaison for the sustainability industry and has worked for Earth Advantage since 2012. Ryan earned his Bachelor of Science in Anthropology from University of Oregon. He holds certifications for Sustainable Homes Professional (SHP), Emerge Leadership and Bonneville Power Administration Performance Tested Comfort Systems (PTCS).
