Energy Trust of Oregon ductless heat pump bonus

Oregon homeowners can get a \$200 bonus for qualifying ductless heat pumps installed by November 30, 2014, in addition to the standard incentive. Also through November 30, owners of manufactured homes can get a \$500 bonus. Portland General Electric and Pacific Power customers are eligible for one bonus per home.

Enter the promotional code **2014TA** on incentive applications to ensure your customers receive the bonus.

See the program information sheet 320I for ductless heat pump installation requirements. Only projects installed between July 1 and November 30, 2014, will qualify. Existing single-family homes, Home Performance with ENERGY STAR®, Savings Within Reach and existing manufactured homes projects qualify for the bonus. Applications for single-family projects must be received within 90 days of installation, and applications for all other programs must be received within 60 days of installation.
