What is SB1536?

In response to the dome here event of 2021, during which at least 100 Oregonians died of heat related illness, often in their own homes, the legislature passed SB1536.

SB1536 directed Oregon Department of Energy to develop a \$10million heat pump deployment program, create a \$5million program for heat pump installations by landlords, fund a \$2million Community Cooling Center, and conduct a cooling needs study to identify existing cooling as well as barriers to cooling access in government supported hosing.

With us in January representing ODOE will be Christy Splitt and Will Mulhern, they will cover who is eligible for program assistance how to be a part of programs and of course the reporting process. They will be on hand to answer any and all questions. Please come prepared!




Breaking News: EPA Extends Sell Through for R-410A Split Systems

On December 20, 2023, EPA released an interim final rule to amend a provision of the Technology Transition rule, which was published in October 2023. This rule allows for inventory of higher-GWP HFC equipment manufactured or imported before January 1, 2025, to be installed until January 1, 2026.

The Technology Transition rule had specified a January 1, 2025, hard stop date for the installation of new split system heat pump and air conditioning systems. This interim rule will extend that by one year, allowing the industry to install existing inventory of these systems.

This rulemaking also clarifies that residential ice makers are not included in the household refrigerator and freezer subsector and are not subject to the restrictions for that subsector. It will become a finalized rule when it is published in the federal register and will be open for comment.
